Horseshoe Cabin R800 Sleeps 2 Bunk beds, bathroom (size of a container home)

Lapa Cabin R850 Sleeps 2 Fully equipped with bathroom, open plan.

- **Gate Control:** Visitors must report to the office. Office closes at 6pm.
- **Occupancy:** Chalets and camping sites may be occupied from **13h00** and must be vacated by **10h00**.
- **Departure:** Please notify the office before vacating the chalet. A staff member will check the chalet.

NO MUSIC ALLOWED, WE HAVE A ZERO NOISE POLICY

- **Smoking is prohibited in the chalets and ablution block:** Ashtrays are for outside use.
- **Valuables:** Ensure that loose valuables are packed or locked away. Bicycles must be chained.
- **Vehicle speed limit is strictly 10km.**
- **Camp hose pipes:** May not be used by guests for any reason whatsoever. No filling up of on-board water storage units.
- **Water:** No water from the Resort is to be used for the washing of vehicles.
- **Power plugs:** Each site is permitted the use of 1 plug. Any extra usage will be charged for.
- **Fires:** Permitted in a designated braai or portable Weber. Please do not put drums directly on the ground.
- **Campers:** are requested to use "fishnet" underlays
- **No mobile water cooling units, stoves, fans or heaters may be used outside at any time.**
- **Pets:** Pets are to be kept under control, on a leash, and are not allowed in the pool area, or to chase animals
- **No picking of fruit or removal of wood:**
- **Septic tanks** are in use at the Resort. Please do not dispose of foreign objects in the toilets. Do not throw food or fat down the drains.

All guests will be held accountable for damages that he/she may have caused at the resort and will be held liable for replacement value of such damage.
